# Maryland Court of Appeals Rules that Teen Sexting Counts as Distributing Child Porn

For a discussion of this case that was decided last month, see this article in which Catholic University Law Professor Mary Leary is interviewed. The teen girl charged has had a profound effect on her life. The twists and turns of the case are complicated — and in their decision, the Appeals Court actually called on Maryland legislators to reform the law, so it is expected to be the subject of much debate during the next session of the Md. General Assembly. The girl is referred to by her initials "S.K." She initially shared the video of herself and a male peer engaging in sex acts with two friends. After a falling-out, those friends allegedly distributed the video to others at their high school. The video made its way to the school resource officer by way of the estranged friends, and that officer met with a crying S.K. to collect a written statement that she thought would help stop the video's dissemination. The statement was referred to the State Attorney, who charged S.K. with filming (a charge that was later dropped), distributing and displaying child pornography.
